



This vacation offer provides 2 adults with airline tickets for flights within the continental US only. (No flights to Alaska or Hawaii).

1. To be eligible for this offer you must be at least 21 years of age, and have a valid major credit card. Ground accommodations of at least 7 consecutive nights must be booked with the fulfillment company to take advantage of this offer. 2. Please complete the activation form and mail it by certified mail to the address listed below. Please include a refundable deposit of \$99.00 in the form of a cashier check only made payable to . The envelope must be postmarked no later than 21 days from the Sponsor's issue date.
3. Upon receipt of your activation form and deposit, you will be mailed a reservation request form with instruction for requesting your dates and destinations. First you will choose the nearest major airport to your home as well as a destination city that has a major airport(Major airports per IATA). Then, choose 2 separate travel dates allowing at least 60 days before your first travel request, and 45 days between the first and second date.
4. All bookings are subject to the availability of fulfillment company's allotments. The fulfillment company reserves the right to substitute a different itinerary When allotments are full. You will be responsible for a reservation processing fee, transportation to and from the airport, taxes, fees and any surcharges. During peak seasons, conventions, and holidays a surcharge will apply. Any monies owed must be received before confirming airline tickets.
5. When your reservations are confirmed, the fulfillment company will prepare and mail a written confirmation with your itinerary. Please note that while advance notice is recommended, correspondence is not issued until 15 to 21 days prior to your pickup date. Your tickets will be issued electronically and you are responsible for having the correct documents required for air travel. It is important that you do not make any travel arrangements until you receive your written confirmation.
6. Cancellation Policy: If you cancel a confirmed flight you will not be allowed to reschedule, nor will your \$99.00 deposit be returned.
