

Terms of Participation

1. In order to take advantage of this offer, you must complete and return the Registration Coupon below via certified mail so that it arrives within 21 days of your sponsor's issue date. 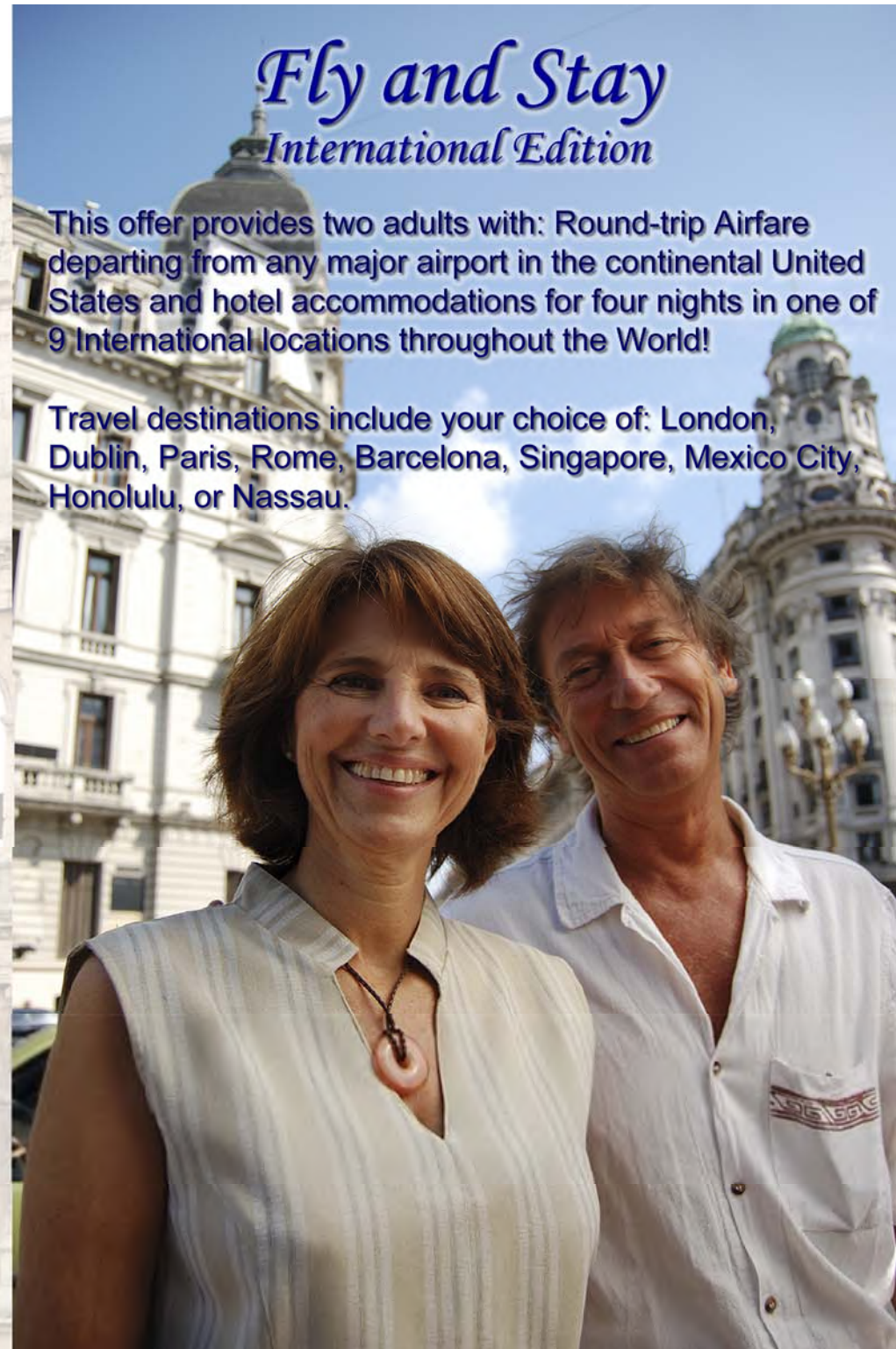
