

ACTIVATION REQUIREMENTS

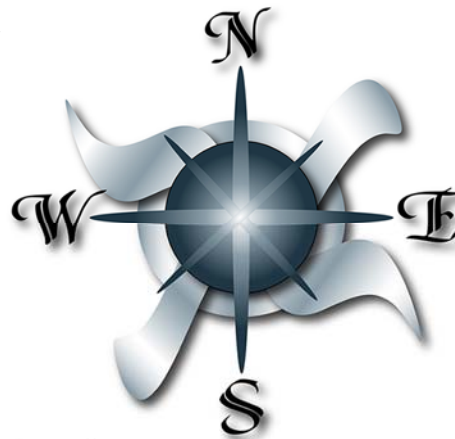

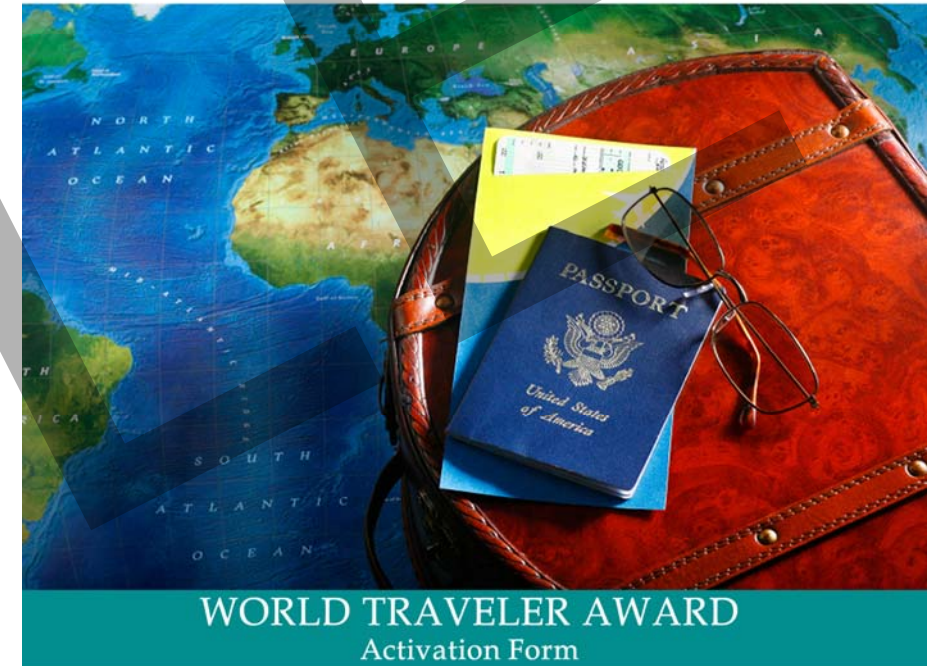
